**8 Information regarding the processing of personal data**

The controller of your personal data is **Oborová zdravotní pojišťovna zaměstnanců bank, pojišťoven a stavebnictví**, CIN: 471 14 321, with its registered office at Praha 4, Roškotova 1225/1, Postal Code 140 00, registered in the Commercial Register maintained by the Municipal Court in Prague, file number A 7232, (hereinafter referred to as 'OZP'). The contact details of the OZP Personal Data Protection Officer are: e-mail: dpo@ozp.cz, telephone: 261 105 196, address of the OZP registered office.

The purpose of the processing of personal data is the **implementation of public health insurance** on the basis of Act No. 48/1997 Coll., on public health insurance, as amended, Act No. 280/1992 Coll., on departmental, branch, company and other health insurance companies, as amended, and Act No. 592/1992 Coll., on public health insurance premiums, as amended. The legal basis for the processing is Article 6(1)(c) of Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), (hereinafter referred to as the 'Regulation'), it is the processing of personal data that is necessary for the fulfilment of a legal obligation to which the OZP, as a health insurance company, is subject.

The provision of basic personal data is a legal requirement and the insured is obliged to provide personal data for this purpose (otherwise it will not be possible for the OZP to comply with the legislative purpose of processing). The provision of the data referred to in point 2 above is voluntary and serves to ensure effective communication between you and the OZP. The OZP may also send you information and news about its activities and services aimed at health promotion. The OZP will retain your personal data for the duration of the insurance relationship and for 10 years after the termination of the insurance or the settlement of all mutual obligations, and for as long as necessary for the purposes of recording covered health services.

You have the right to request access to personal data and information from the OZP pursuant to Article 15 of the Regulation, the right to rectification (completion) of personal data pursuant to Article 16 of the Regulation or erasure on the grounds set out in Article 17 of the Regulation or restriction of processing pursuant to Article 18 of the Regulation, the right to object to processing pursuant to Article 21 of the Regulation, and the right to lodge a complaint with the supervisory authority, which is the Office for Personal Data Protection. If a particular personal data breach is likely to result in a high risk to the rights and freedoms of natural persons, the OZP will notify you of the breach without undue delay.

OZP is entitled to use your name, surname, address and electronic contact details for the purpose of sending you information and news about its health promotion activities and services on the basis of legitimate interest under Article 6(1)(f) of the Regulation. You have the right to object to this use of your personal data at any time, on the basis of which OZP will no longer process your personal data for this purpose. Similarly, because of the legitimate interest in protecting personal data against misuse, the OZP may ask you to make a monitored verification call solely for the purpose of confirming the submission of this application.

**9 Consent to receive offers of products and services from OZP health promotion partners**

In accordance with Article 6(1)(a) of the Regulation, you can give your free, specific, informed and unambiguous consent below to the processing of your personal data in the scope of name, surname, address and electronic contact details for the purpose of sending offers of products and services of the OZP contractual partners listed on the OZP website [www.ozp.cz](http://www.ozp.cz). The offers relate to health promotion. Giving consent is voluntary and has no effect on the relationship between you/your child and OZP. In addition to the rights set out above, you have the right to withdraw your consent at any time, in writing to OZP at Roškotova 1225/1, 140 00 Praha 4 or at [dpo@ozp.cz](mailto:dpo@ozp.cz), and the right to data portability under Article 20 of the Regulation.

In case of your interest, you and the child you represent can set up free access to the secure VITAKARTA portal via our website [www.ozp.cz](http://www.ozp.cz), where you can remotely access your personal account with data on services covered by public health insurance pursuant to Section 43(2) of Act No. 48/1997 Coll. This portal also serves as a communication channel with OZP and you can, for example, use it to access benefits provided by OZP.
